

Security Light System Contract

AGREEMENT MADE THIS THE I	OAY OF,	BETWEEN		
Elberton Utilities Electric Division (her	einafter called the "Utility"), a department of the City of		
Elberton, a municipal corporation organized and existing under the laws of the State of				
Georgia, and	_ (hereinafter called the "C	ustomer").		

WITNESSETH:

- 1. The Utility shall construct and operate an ELECTRIC SECURITY LIGHT(S).
- 2. The Customer shall pay the Utility for all services furnished hereunder at the rates and on the terms and conditions set forth here below or as amended from time to time in the Rates and Fees schedule of the City of Elberton, such payment shall be made in accordance with the usual and customary billing procedures used for all utility bills of the City of Elberton.
- 3. The Customer shall be responsible for paying the fee per month for a minimum of 24 months after the date of this agreement first written above. If the light as removed at the Customer's request prior to the minimum of 24 months from the date of this contract, then the Customer shall pay the Utility the entire amount of the contract for the 24 month period at the usual monthly rate.
- 4. Replacement of the light fixture bulb within the term of this contract will be the responsibility of the Utility if the bulb ceases to operate due to normal wear and tear. The cost of bulb replacement, including labor and material, will be responsibility of the Utility.
- 5. Repair of the light fixture, including the bulb, due to physical damage, either intentional or unintentional, whether caused by the Customer or some other party, whether known or not known, will be performed by the Utility at the written request of the Customer. However, the Customer will be responsible for the cost of the repairs to include material and labor costs. The costs of the repairs will be invoiced to the customer on the regular monthly utility bill, and payment of the invoice will be governed by the Utility's usual policies and procedures for collecting payment.
